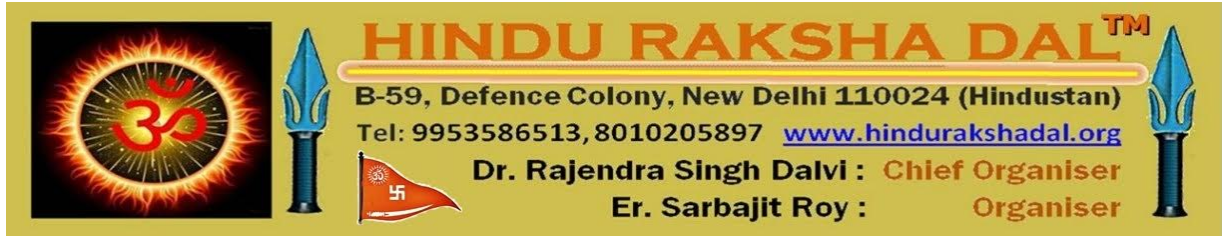

SUB: Representation to National Task Force for Doctor Safety, submitted by Hindu Raksha Dal

We,, the executive of the HINDU RAKSHA DAL, an ancient association of Hindustanis to protect Hindus within and without India, on this auspicious day of Janamasthami, are constrained to submit this brief representation concerning your remit.

1. We Hindus are deeply concerned that after the unfortunate episode which occurred on 09.08.2024, certain significant social media intermediaries owned by USA based foundations (linked to foreign intelligence agencies of countries opposed to India's sovereignty, unity and territorial integrity) were blatantly misused to give a communal flavour so as to bring out persons of different communities onto the streets of Kolkata to create violence directed at higher caste Hindus.

2. We Hindus are also deeply concerned that the TWITTER social media platform, which though nominally US owned is actually a Chinese propaganda outlet through their puppet Mr. Elon Musk, published several messages that 3 Muslim doctors namely a) Dr. Shabaz Khan, b) Dr. Arsean Alam and c) Dr. Golam Azam, doctors of the said hospital, had gangraped and murdered the victim, and thereafter one Mr. Sanjoy Roy was forced to have sex with the dead body of the victim, as per tweets of Ms. Madhu Kishwar and Ors. 3. We Hindus are also deeply concerned that the WIKIPEDIA social media platform, which is a CIA front organisation, had published the name of the victim, in complete breach of India law and Supreme Court directions and has refused to delete the same despite several requests to do so. It is pertinent that the said name of victim was published by the Wikipedia registered User in India one "Velicharla Sai Sankeerth" with d.o.b September 16, 2005, Nationality: Indian and Country:India.

We Hindus have carefully noticed that Govt of India took no effective steps against these large and significant social media entities (Atheist/Communist and Judeo-Christian controlled respectively) which were vying which each other to communalise the issue to polarise Hindustani (Hindu and Muslim) people against each other on religious lines.

5. We Hindu have also noted that, strangely the Govt of India had not taken swift disciplinary action against the Union Home Secretary Mr. Ajay Kumar Bhalla, who allowed M/s Wikipedia to organise an international conference of DEOBANDI MUSLIM secessionists organised by WIKIMEDIA FOUNDATION at Hyatt Hotel, Gachibowli, Hyderabad, from 28th to 30th April 2023, and earlier at IIIT Hyderabad in March 2023, which was organised by CIA agent Mr. Asaf Bartov. Visas were granted despite the MHA, IB and Border Management having received full advance warning of these meetings. Because these complaints against Shri Ajay Bhalla were forwarded to Cabinet Secretariat by the DoPT vide F. No. 104/52/2023-AVD-IA (pt.5) , we of the Hindu Brotherhood are shocked to see that Shri Ajay Kumar Bhalla is now a member of this National Task Force to protect our Hindu female working professionals considering his past dismal track record and failing to crackdown on CIA and Islamic State activities in India.

Accordingly we pray for National Task Force to recommend the following for which we shall be obliged

PRAYERS

1. That stringent steps be taken to regulate social media entities who must be compelled to promptly take down offensive messages under Indian laws and not under their own policies and USA's laws.
2. That Wikimedia Foundation Inc. (USA) be immediately directed to submit to Indian law by appointing their Resident Grievance Officer and Resident Chief Compliance Officer in India under the IT Act Social Media Intermediary Guideline Rules 2022, or else their intermediary status be formally nullified so their local employees and contractor in India can be arrested and prosecuted.
3. That Working of the Interdepartmental Committee for blocking of websites be directed to sit weekly and to take vigorous action against communally polarising posts with powers to direct blocking of specific social media accounts.
4. That vigorous action under Indian Penal laws be taken by Union Home Secretary to arrest and prosecute a) Mr. Velicharla Sai Sankeerth and b) Ms. Madhu Kishwar for aforescribed seditious acts affecting the unity of India.
